

**1994 CCST GAS PIPING ORDINANCE**

**TOWNSHIP OF BAINBRIDGE  
BERRIEN COUNTY, MICHIGAN**

**Ordinance  
No. 38  
No. 26 A**

Adopted: October 3, 1994

Whereas, Section 105 of the Uniform Mechanical Code (1994 ed.), as adopted by Bainbridge Township, Berrien County, Michigan, provides for the use of alternate materials and methods of construction approved by the building official, and

Whereas, the Michigan State Construction Code Commission in accordance with the authority granted under Section 21, Act 230, PA 1972, as amended, being Section 125.1521 of the Michigan Compiled Laws, on the recommendation of the Michigan Mechanical Board, has issued certain Certificates of Acceptability to various manufacturers of corrugated stainless steel tubing (CSST) interior gas piping systems,

It is resolved by the Bainbridge Township Board of Trustees that CSST interior gas piping systems may be installed within the jurisdiction of Bainbridge Township provided the following conditions are met:

1. Manufacturers have received Certificates of Acceptability from the Michigan State Construction Code Commission in accordance with the authority granted under Section 21, Act 230, PA 1972, as amended, being Section 125. 1521 of the Michigan Compiled Laws, on the recommendation of the Michigan Mechanical Board.
2. Copies of such Certificates of Acceptability have been provided to the Bainbridge Township Building Department prior to installation.
3. Systems shall be installed in accordance with the manufacturer's installation instructions, 2 copies of which must be on file with the Bainbridge Township Building Department.
4. Such systems shall comply with the gas piping testing procedure required by the Mechanical Code adopted and enforced by Bainbridge Township.
5. Such systems shall not have any tees installed in the system other than in an iron pipe site-built manifold that does not contain any close nipples. Manufactured manifolds may be used.

The undersigned, Beverly Koroch, certifies that I am the duly elected clerk of Bainbridge Township and that at a meeting of the trustees thereof, convened and held in accordance with law on October 3, 1994, this resolution was passed and that such resolution is now in full force and effect.
