PUBLIC HEARING FOR DEBRA L. MULLEN (WALKER):

- Motion by DeLapa/Weber to suspend Regular Meeting and open Public Hearing at 7:02 pm.
- Chairman Bjes summarized the reason for this hearing request. Debra Mullen is requesting a land variance for keeping her mule. She owns 2.21 acres and Bainbridge Township requires 3 acres.
- Mullen would like to keep the animal until they move, or the mule passes.

PUBLIC COMMENT:

- Matthew Lowe, 1806 S. Park Rd. Benton Harbor An emotional support animal is not considered a service animal. A mule is not a service animal. The pen is too close to neighboring properties.
- Donna Faulkner, 1830 S. Park Rd., Benton Harbor Mullen wanted to rent Faulkner's property for her 1 or 2 mules. Falkner did not see a contract; Mullen signed Faulkner's name on contract; no rent paid. The mule destroyed trees and plants. Mullen did not clean up mule area, and the quality of care for the animal was not noticeable.
- Ryan Schilke, 1860 S. Park Rd., Benton Harbor Mullen is not a good neighbor and doesn't show good care for the animal. Mullen's property runs at the back of Schilke's property and there is not enough acreage to keep the mule.
- Richard Lowe, 1806 S. Park Rd., Benton Harbor Pen is too close to neighboring properties. Manure smell
 is too much.
- Dan Mullen, 1786 S. Park Rd., Benton Harbor She needs to pet animal because of her anxiety issues.

CLOSED PUBLIC HEARING:

Motion by Bjes/Weber to close Public Hearing at 7:20 pm.

Voice Vote: Yes---all; No---none.

BOARD DELIBERATION:

- Zaluckyj Visited site and said the care of the mule was good; clean, water and food available.
- DeLapa Maximum number of acres (3) has not been met no matter how many animals she has. She cannot meet any of these issues: 3-acre minimum, setbacks, manure pile.

• Weber – She does not have adequate medical documentation.

Zoning Board of Appeals member DeLapa made a motion and supported by member Weber to deny the application for a variance allowing Mullen to keep a mule on her property.
